Piranha Lox Tool Tray

Subject: Piranha Lox Tool Tray

Subject to the terms and conditions of this letter, Genie Industries Inc. authorizes the owner of Genie scissor lifts to modify/use their Genie equipment based on the requirements hereinafter.

Warning:

Failure to comply with all restrictions, instructions and warnings contained in this letter, the Operators Manual and the applicable safety or owner’s manual could result in death or serious injury.

Modification Description:

Installation of an aftermarket Piranha Lox Tool Tray on Genie slab scissor lifts.

Owner/Employer/User/Operator Requirements:

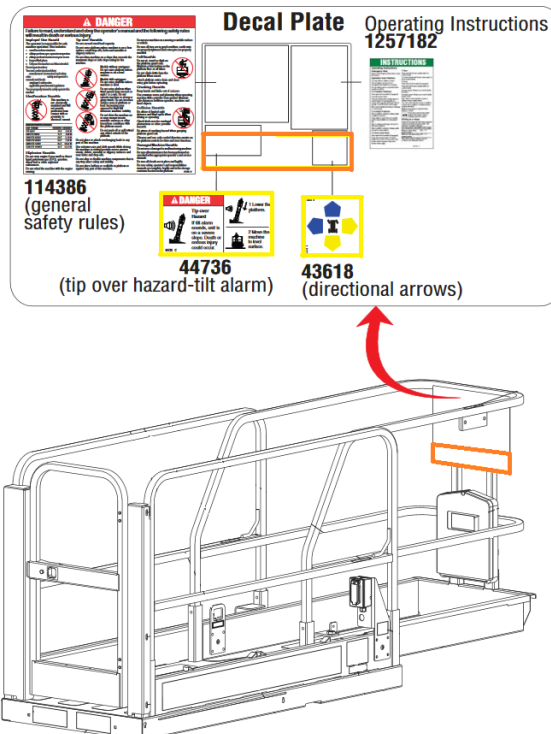


Figure 1: Tool Tray Layout

- 1) The Piranha Lox Tool Tray shall only be mounted in the center of the front of the extension deck at a maximum height of 32 inches from the extension deck floor (to the top of the tray), on the extension deck decal plate, inside the perimeter of the platform railing (approximate location highlighted in orange in Figure 1). The Piranha Lox attachment should only be drilled or riveted onto the platform decal plate, not the platform railing.
- 2) The Tip Over Hazard-Tilt Alarm decal (P/N 44736) and Directional Arrows decal (P/N 43618) decal (highlighted in yellow in Figure 1) must be removed from the decal plate and installed on the front of the Piranha Lox Tool Tray. All decals on the decal plate must be visible to occupants inside of the platform.

- 3) The maximum combined weight of the tool tray and contents held by the tray must not exceed 50 lbs.
- 4) When the tool tray is installed, the maximum load capacity of the extension deck must be restricted to 230 lbs., with a maximum of 1 occupant (load includes all occupants, equipment, and tool tray).
- 5) When the tool tray is installed, the total rated load of the scissor lift must be restricted to 480 lbs., with a maximum of 2 occupants (load includes all occupants, equipment, and tool tray).
- 6) No modification to the Genie equipment, or use of it outside the proposed application, is permitted outside the approval criteria contained hereinafter.
- 7) A copy of this letter must accompany the operators manual at all times in the weather resistant storage compartment located on the equipment at the job-site where this modification/application is approved and authorized by the user/employer.
- 8) Fabrication, attachment, and use of a Piranha Lox Tool Tray must be approved and authorized by the equipment owner.
- 9) It is the responsibility of the equipment owner and/or operator to perform a hazard analysis on the design, installation, and use of the Piranha Lox Tool Tray, and to ensure that the equipment complies with the essential health and safety requirements applicable to the jobsite, as well as local, state, provincial, and federal rules and regulations, and standards related to the use of the equipment.
- 10) The installation of the Piranha Lox Tool Tray must be engineered specifically for the application by a qualified person in compliance with the stability and structural requirements of the equipment and if required, include third party certification. A “qualified person” as used above is one who, by possession of a recognized degree, certificate, or professional standing, or by extensive knowledge, training and experience, has demonstrated his/her ability to solve or resolve problems related to the subject matter, the work, or the project.
- 11) Operators must be trained and qualified how to safely operate the modified equipment, or use it in the proposed application, and be familiar with the specific model of Genie equipment as follows:
 - a) Be familiar, and comply, with the equipment operating and safety manuals.
 - b) Understand all control functions, decals and warnings.
 - c) Be aware of and understand all safety devices specific to the equipment being used.
 - d) Be instructed regarding the specific hazards associated with using the Genie equipment, in its modified state, or in the proposed application, and utilize all means, including those provided by the user/employer, to avoid them.
- 12) The user/employer and the operator shall comply with all applicable jobsite, local, state, provincial, or federal rules, regulations, and standards related to the use of the equipment and its modification.
- 13) The Genie equipment must be in proper working condition and configuration.
- 14) The Piranha Lox Tool Tray should not interfere with, or obstruct, the safe use or normal operation of the machine in any way, including but not limited to:
 - a) lanyard attachment points
 - b) operator controls
 - c) entry and exit points etc.
 - d) moving components
 - e) control systems
 - f) decals



Additional Requirements:

In consideration for Genie's authorization herein, the equipment owner hereby agrees to indemnify and hold harmless Genie Industries Inc. and its parent and affiliated companies against any and all liability, claims, suits, losses, costs and legal fees caused by, arising out of, or resulting from the approved modification/application of the Genie equipment; any negligent act in the operation of the equipment by the owner, user and/or operator; the failure to comply with the criteria set forth in this letter related to the modification/application; the design, manufacture and installation of any modification; the safety rules and operating instructions in the Operator's Manual; the design and placement of any safety decals; the operation of the equipment by the owner, user and/or operator; and any negligent act or omission related to the equipment, its use or its modification.

BY PROCEEDING WITH THE MODIFICATION/APPLICATION AUTHORIZED HEREIN, YOU AGREE TO THE CONTENTS OF THIS LETTER AND ITS CONDITIONS. IF YOU DO NOT AGREE, DO NOT PROCEED WITH THE PROPOSED MODIFICATION/APPLICATION.
